#### **DEVELOPMENT REVIEW BOARD MEETING**

1. DRB/PC Vice Chair, Bob Hartenstein called the meeting to order 5:31 p.m.
2. Approval of the minutes of the July 14, 2022, DRB/PC meeting
  - a. Kirsten moved to accept the minutes as written, Bethanie seconded. All in favor; the motion passed.
3. David Martini Hearing – Review Proposed Waiver for Shed placement next to property line.
  - a. David submitted signatures from three adjacent property owners stating they have no objections to the shed placement setting one foot from property line. It is a non-conforming lot and there exist previous approval in that neighborhood.
  - b. David requested one foot off and the DRB requested five feet off the property line.
  - c. Kirsten moved to approve three feet off the property line, Bethanie seconded. All in favor; the motion passed.
4. Monthly Report from the Zoning Administrator and any updates on permit activity.
  - a. David sent a letter to Silva requesting a call. Property Owner put an extension roof over 64 square feet.
  - b. Per Section 5:27 of the zoning ordinance, David requested Kirsten to submit a photograph of the solar arrays placed in her yard, showing that only 5% of the view has been compromised. Once received he can sign off the permit. A building permit is not needed when solar arrays are on a building, but one is needed when they are free standing. Page 36 of the zoning ordinance shows an example of the photo needed.
5. No New or Old Business to discuss.

  - a. Bethanie moved to adjourn the meeting. Annie seconded. All in favor, the meeting adjourned at 5:39 p.m.
